A few years ago, we were privileged to receive a significant Gift in a Will from someone who wanted to help our organisation to continue to thrive. The gift was unrestricted, and we chose to direct it towards settling the loan on our London office, giving us a permanent home from which to run our services.

OUR SERVICES INCLUDE:

- Group Work, so children, young people and adults can meet weekly and develop their social and communication skills and, more importantly, have fun.
- Family Support, with groups for parents and carers to share experiences, develop new strategies and meet together freely and without judgement.
- Community Outreach, with weekly 1:1 support for individuals to build practical skills and help them to navigate life's challenges.
- Art and Music Therapy, for adults and children of all ages, verbal or non-verbal, to discover new means of self-expression.
- Adult Support, helping autistic adults to develop the skills needed to gain volunteering opportunities and paid employment.
- Training, whether for teachers or social workers, whether for those working in homeless shelters or large corporations, who wish to create inclusive neurodiverse environments and change the narrative around autism once and for all.
- Crisis intervention, with immediate home visits for families at breaking point by specialist staff.
